- iii. Discussion: Increase to \$15,743 from \$15,00 in errors and omissions insurance because of the increase in tax funding. The insurance year will be changed to end on the end of our fiscal year budget. If we need to increase the total budget, we will have to submit a budget amendment to the full County Board. Mr. Holcomb suggests that we take the \$743 from the community engagement line item.

G. Discussion Items

- 1. Q1 Outcomes Report
 - i. 55% are completed or in progress. Some delays that are mostly hiring issues. We are on track to meet many of the goals. The major common challenge is the workforce. There is a national crisis being dealt with on a statewide level. A few highlights were covered.
- 2. Funding Policy Update
 - i. Updates are being made in coordination with the legal counsel. We will need to articulate that this is an expenditure-based grant with reimbursement for approved expenses. One point that requires more discussion (action item next month) is the three-year requirement for organizations to apply with us. This would not be required for collaborative organizations, so formalizing this in the funding policy.
- 3. Program Year 2022 2023 Grant Application
 - i. Updates to funding policy in coordination in legal council for clarity. Addition of discussion of accepting new organizations (under three years) to join forces with pre-existing (over three years) organizations.
 - ii. We are proposing two tracks of applications: renewal as well as new.
