 - i. Notes: Presented about 988 Crisis Care System. Crisis Care Continuum must evolve to better meet the needs of people in crisis and distress. Vision – 988 serves as America's mental health safety net. 988 will reduce suicides and mental health crises and provide a pathway to well-being. Crisis Call Centers will dispatch mobile crisis teams to individuals in mental health or suicidal crises rather than police or EMS and greater coordination around access to care options like crisis stabilization units and living room programs for peer support.
