- **1. Youth Mental Health System of Care Collaborative Data Presentation:** Dr. Jyoti Kolodziej, Brittney Fry, Kristina Redington, & Joseph Kreul.
 - i. Notes: Youth Mental Health System of Care (YMHSoC) is a comprehensive, coordinated, equitable, and evidence-based youth mental health system of care affordable and accessible for all children, youth, and adults ages 0-21 in Winnebago and Boone counties. In 2019, the Youth Mental Health System of Care did a gap analysis that targeted clinicians and other providers in the area to see what services were being offered, what kind of gaps and barriers in the care, and access to services for patients in the community. Then in 2021, a survey was conducted that targeted consumers or would be consumers in the 0-21 age range or families with individuals who could have access to mental health services in the community to see what their experience was, what were successes, and what barriers there were. Results from the 2021 survey mirrored the surveys from 2019. Presenters then went over results from surveys.

If it gets approved at the August Board Meeting, we can start doing requests for quotes for specific types of services, such as a Rideshare Program, so transportation is not a barrier to making a mental health appointment.
