 - c. Budget template was shared with the group. Budget projection includes:
 - Creative suite- \$960 for Adobe
 - RFP technology costs- \$7,000 for SurveyMonkey
 - Webconferencing- \$180 for Zoom costs
 - Email outreach/engagement- \$240 for Constant Contact
 - Data dashboard hosting fee (prorated)- \$2,500 for iDashboards
 - Email Mailbox service- \$753.12 for County DOIT
 - Website hosting- \$240 for County DOIT
 - IT support- \$4,140 for County DOIT
 - IT (domain registration and email configuration)- \$345 for County DOIT
 - Public engagement- \$4,800
 - Postage, printing, advertising-\$4,800
 - RFP Public Notices-\$600
 - Logo- \$1500
 - Legal Counsel- \$1500 in case it is needed
 - Travel- \$1000 to attend the Association for the Community Mental Health Authorities (ACMHAI) meetings when held in-person.
