Once Dennis Elementary School, 730 Lincoln Park Boulevard is a 7.37-acre lot on the west side of Rockford. Following the school's closure and demolition, Rockford Public Schools donated the lot to the Northern Illinois Land Bank Authority (NILBA) with the intention of land revitalization. Due to the location and size of the property, NILBA is seeking land use proposals that will give back to the community. Some possible uses for this land may include, but are not limited to, urban agriculture, housing, renewable energy, recreation, etc. There is no restriction on eligible applicants—NILBA encourages all entities to apply, including non-profit organizations, for-profit organizations, and individuals. NILBA seeks to sell the parcel to a new owner to revitalize the land. The purchase price of the lot is negotiable based on project merit. Proposals will be reviewed on a rolling basis by Region 1 Planning Council in partnership with the City of Rockford beginning on December 8, 2023. Finalists will be chosen and notified for further discussion on the submitted proposal. Please complete the following application and submit to property@r1planning.org.


