The Northern Illinois Land Bank Authority (also referred to as "Land Bank,") requests a response from all qualified and
 responsible Respondents who have the capability, experience, capacity and financial wherewithal to <u>construct new</u>
 <u>single-family houses</u>. At this time, up to two new houses would be built annually.

- Responses will be evaluated to determine if the Respondent has the required knowledge, expertise, and experience to
 fulfill requirements. The Land Bank may, but is not required to, proceed with negotiations to further determine the
 budget, scope, and deliverables.
- 11 Responses that do not adhere to the requirements herein may not be considered. Please read the entire solicitation 12 package and submit a response in accordance with the instructions. All forms and signature areas contained in the 13 solicitation package must be completed in full.

15 ABOUT R1 AND THE LAND BANK

- 16 Region 1 Planning Council (R1) is a *special-purpose, regional government agency*. Regional councils are public 17 organizations comprised of local elected officials that promote collaboration among local governments, working across 18 the jurisdictional silos of states, counties, and municipalities. R1 supports a well-informed, comprehensive dialogue that 19 holistically addresses regional issues by fulfilling the needs of government entities for long-range planning, securing 20 funding, and analyzing and providing data in support of regional projects and initiatives.

- The Illinois Housing Development Authority has awarded Region 1 Planning Council grant funding to form the Northern
 Illinois Land Bank Authority. The Land Bank gives local governments more control over abandoned properties in their
 communities.
- 25 AVAILABLE PROPERTIES
- A number of potential sites with site control have been identified in Rockford, IL and Winnebago County but exact
- 27 locations of builds have not been determined. In general, the sites will be in neighborhoods near Rockford's downtown
- in areas that haven't seen new construction for a number of years. Sites are considered buildable, some with previous
- 29 homes demolished on the site.

- FVALUATION: R1 determines how well Responses meet the Responsiveness requirements. R1 will rank Proposals,
 without consideration of price, from best to least qualified using a point ranking system (unless otherwise specified)
 as an aid in conducting the evaluation. Respondents who fail to meet minimum requirements or who receive fewer
 than the minimum required points, if any, will not be considered for price evaluation and award.
- 116 R1 evaluates three categories of information: Responsiveness, Responsibility, and Price. R1 considers the information 117 provided and the quality of that information when evaluating Proposals. If R1 finds a failure or deficiency, R1 may reject 118 the Proposal or reflect the failure or deficiency in the evaluation.
- **8. RESPONSIVENESS**: A Responsive Respondent is one who submits a Proposal that conforms in all material respects
 to the Request for Proposal, and includes **all required** forms.
 - a. R1 will determine whether the Proposal meets the stated requirements. Minor differences or deviations that have negligible impact on the price or suitability of the supply or service to meet R1's needs may be accepted or corrections allowed. If no Respondent meets a particular requirement, R1 may waive that requirement.
 - b. When the specification calls for "Brand Name or Equal," the brand name product is acceptable. Other products will be considered with proof that the other product meets stated specifications and is equivalent to the brand product in terms of quality, performance and desired characteristics.
 - c. R1 will determine whether the Proposal complied with the instructions for submitting Proposals. Except for late submissions, and other requirements that by law must be part of the submission, R1 may require that a Respondent correct deficiencies as a condition of further evaluation.
- **9. RESPONSIBILITY**: A responsible Respondent is one who has the capability in all respects to perform fully the contract requirements and who has the integrity and reliability that will assure good faith performance. R1 determines whether the Respondent is a "responsible" Respondent; a Respondent with whom R1 can or should do business.
 For example, R1 may consider the following:

A "prohibited bidder" includes any person assisting an employee of R1 by reviewing, drafting, directing, or135preparing any invitation for bids, a request for proposal, or request of information, or providing similar136assistance unless such assistance was part of a publicly issued opportunity to review drafts of all or part of these137documents. - contracts with the agency to write specifications for a particular procurement need shall submit a bid or proposal or receive a contract for that procurement need.
- b. Nothing herein is intended to prohibit a vendor from bidding or a Proposal from suppling developing technology. 142 goods or services after providing R1 with a demonstration of the developing technology, goods, or services; 143 provided the subject of the demonstration to R1 represents industry trends and innovation and is not specifically 144 145 designed to meet R1's needs. Nothing herein is intended to prohibit a person or business from submitting a bid or Proposal or entering into a contract if the person or business: (i) initiates a communication with an employee 146 to provide general information about products, services, or industry best practices and, if applicable, that 147 communication is documented in accordance with Section 50-39 of the Illinois Procurement Code or (ii) 148 responds to a communication initiated by an employee of R1 for the purposes of providing information to 149 evaluate new products, trends, services, or technologies. 150
- c. Other factors that R1 may evaluate to determine responsibility include, but are not limited to: political contributions, certifications, conflict of interest, financial disclosures, taxpayer identification number, past performance in business or industry, references (including those found outside the Proposal), compliance with applicable laws, financial responsibility, insurability, effective equal opportunity compliance, payment of prevailing wages if required by law, capacity to produce or sources of supply, and the ability to provide required maintenance service or other matters relating to the Respondent's ability to deliver in the quality and quantity within the time and price as specified in this solicitation.
- 158d. Awarded Respondents must at all times have financial resources sufficient, in the opinion of R1, to ensure159performance of the contract and must provide proof upon request. R1 may require a performance bond if, in160the opinion of R1, it ensures performance of the contract. R1 may terminate the contract, consistent with the161termination for cause provision of the contract, if the vendor lacks the financial resources to perform under the162contract.
 - e. R1 may require that a Respondent correct any deficiencies as a condition of further evaluation.
- 10. PRICE: R1 identifies the the lowest priced Proposal that meets the responsibility and responsiveness requirements, viz.,
 which proposal provides the smartest budget, accounting for projected development costs, carrying out the
 statement of work to meet R1's specifications, and potential ownership, royalty arrangements, or other value added

2.	 TERM OF CONTRACT: The prospective contract has an initial term of <u>12 months</u>. If a start date is not identified then the term shall commence upon the last dated signature of the Parties. a. Vendor shall not commence billable work in furtherance of the contract prior to final execution of the contract except when permitted in writing by the Agency. b. In no event will the total term of the contract, including the initial term, any renewal terms and any extensions exceed ten (10) years.
	c. Any renewal of the contract is subject to the same terms and conditions as those which apply to the initiat term of the contract, unless otherwise provided in the pricing section. R1 may renew the contract for any of all of the option periods specified, may exercise any of the renewal options early, and may exercise more than one option at a time based on continuing need and favorable market conditions, when in the best interest of R1. The contract may neither renew automatically nor renew solely at the Vendor's option.
3.	RESPONDENT PERFORMANCE. The vendor agrees to perform its obligations demonstrating quality workmanship and completion of all work in a timely manner as shall be judged and determined by R1-designated staff.
4.	TERMINATION FOR CAUSE: R1 may terminate the contract, in whole or in part, immediately upon notice to the Vendor if: (a) R1 determines that the actions or inactions of the Vendor, its agents, employees or subcontractor have caused, or reasonably could cause, jeopardy to health, safety, or property, or (b) the Vendor has notified R that it is unable or unwilling to perform the contract.
	a. If Vendor fails to perform any material requirement of the contract to R1's satisfaction, it is in violation of material provision of the contract. If R1 determines that the Vendor lacks the financial resources to perform the contract, then R1 shall provide written notice to the Vendor to cure the problem identified within th period of time specified in R1's written notice. If not cured by that date R1 may either: (a) immediatel terminate the contract without additional written notice or (b) enforce the terms and conditions of the contract.
	 For termination due to any of the causes contained in this Section, R1 retains its rights to seek any availabl legal or equitable remedies and damages.
5.	TERMINATION FOR CONVENIENCE: R1 may, for its convenience and with thirty (30) days' prior written notice to Vendor, terminate the contract in whole or in part and without payment of any penalty or incurring any further obligation to the Vendor. Upon submission of invoices and proof of claim, the Vendor shall be entitled to compensation for supplies and services provided in compliance with the contract up to and including the date of termination.
6.	AVAILABILITY OF APPROPRIATION: The contract is contingent upon and subject to the availability of funds. R1, a its sole option, may terminate or suspend the contract, in whole or in part, without penalty or further paymer being required, if (1) the Illinois General Assembly or the Federal funding source fails to make an appropriation sufficient to pay such obligation, or if funds needed are insufficient for any reason (30 ILCS 500/20-60), (2) the funding governmental entity decreases the Agency's funding by reserving some or all of the Agency's

appropriation(s), or (3) the Agency determines, in its sole discretion that a reduction is necessary or advisable

- LATE PAYMENT: Payments, including late payment charges, will be paid in accordance with the State of Illinois Prompt Payment Act and rules when applicable. Payment terms contained in Vendor's invoices shall have no force or effect.
 - b. **EXPENSES**: Prior to the execution of a contract by the Parties, even if the effective date of the contract is prior to execution, R1 will not pay for supplies provided or services rendered, including related expenses, incurred.
- c. **PREVAILING WAGE**: As a condition of receiving payment Vendor must (i) be in compliance with the contract, 222 (ii) pay its employees prevailing wages when required by law, (iii) pay its suppliers and subcontractors 223 224 according to the terms of their respective contracts, and (iv) provide lien waivers to R1 upon request. Examples of prevailing wage categories include public works, printing, janitorial, window washing, building and grounds 225 226 services, site technician services, natural resource services, security guard and food services. The prevailing 227 wages are revised by the Illinois Department of Labor (DOL)and are available on DOL's official website, which shall be deemed proper notification of any rate changes under this subsection. Vendor is responsible for 228 contacting DOL at 217-782-6206 or (https://www2.illinois.gov/idol/Pages/default.aspx) to ensure 229 understanding of prevailing wage requirements. 230
 - d. FEDERAL FUNDING: The contract may be partially or totally funded with Federal funds. If Federal funds are expected to be used, then the percentage of the goods/services paid using Federal funds and the total Federal funds expected to be used will be provided to the awarded Vendor in the notice of intent to award.
 - e. **INVOICING**: By submitting an invoice, Vendor certifies that the supplies or services provided meet all requirements of the contract, and the amount billed and expenses incurred are as allowed in the contract. Invoices for supplies purchased, services performed, and expenses incurred through June 30 of any calendar year must be submitted to R1 no later than July 10 of that calendar year; otherwise Vendor may be required to seek payment through the Illinois Court of Claims.
 - f. Vendor shall not bill for any taxes unless accompanied by proof that R1 is subject to the tax. If necessary, Vendor may request the applicable Agency's tax exemption information.
 - g. Vendor shall invoice at the completion of the contract. Exceptions to this term are allowed when, as identified in the contract, invoicing is tied to milestones, deliverables, or other invoicing requirements agreed to therein.
- **8.** ASSIGNMENT: The contract may not be assigned or transferred in whole or in part by Vendor without the prior
 written consent of R1.

245 9. SUBCONTRACTING

- 246a.Subcontractors are not allowed. A subcontractor is a person or entity that enters into a contractual agreement247with a total value of \$50,000 or more with a person or entity who has a contract subject to the Illinois248Procurement Code pursuant to which the person or entity provides some or all of the goods, services, real249property, remuneration, or other monetary forms of consideration that are the subject of the primary250contract, including subleases from a lessee of a contract. If subcontractors are to be utilized, Respondent must251identify subcontractors expected to receive \$50,000 or more annually under the contract and disclose the252expected amount of money each will receive.
- AUDIT/RETENTION OF RECORDS: Vendor and its subcontractors shall maintain books and records relating to the
 performance of the contract and any subcontract necessary to support amounts charged to R1 pursuant the
 contract or subcontract. Books and records, including information stored in databases or other computer systems,
 shall be maintained by the Vendor for a period of three (3) years from the later of the date of final payment under



- 257 the contract or completion of the contract, and by the subcontractor(s) for a period of three (3) years from the later of final payment under the term or completion of the subcontract. If Federal funds are used to pay contract 258 costs, the Vendor and its subcontractors must retain their respective records for five (5) years. Books and records 259 required to be maintained under this section shall be available for review or audit by representatives of: the 260 procuring Agency or other governmental entities with monitoring authority, upon reasonable notice and during 261 262 normal business hours. Vendor and its subcontractors shall cooperate fully with any such audit and with any investigation conducted by any of these entities. Failure to maintain books and records required by this section 263 shall establish a presumption in favor of R1 for the recovery of any funds paid by R1 under the contract or any 264 subcontract for which adequate books and records are not available to support the purported disbursement. The 265 Vendor or subcontractors shall not impose a charge for audit or examination of the Vendor's or subcontractor's 266 books and records. 30 ILCS 500/20-65. 267
- TIME IS OF THE ESSENCE: Time is of the essence with respect to Vendor's performance of the contract. Vendor
 shall continue to perform its obligations while any dispute concerning the contract is being resolved unless
 otherwise directed by R1.
- 12. NO WAIVER OF RIGHTS: Except as specifically waived in writing, failure by a Party to exercise or enforce a right
 does not waive that Party's right to exercise or enforce that or other rights in the future.
- **13.** FORCE MAJEURE: Failure by either Party to perform its duties and obligations will be excused by unforeseeable
 circumstances beyond its reasonable control and not due to its negligence including acts of nature, acts of
 terrorism, riots, labor disputes, fire, flood, explosion, and governmental prohibition. The non-declaring Party may
 cancel the contract without penalty if performance does not resume within thirty (30) days after the declaration.
- 277 14. **CONFIDENTIAL INFORMATION:** Respondent should provide a redacted copy of the Proposal, if applicable, that 278 removes material considered to be a trade secret or competitively sensitive, confidential, or proprietary. Each Party to the contract, including its agents and subcontractors, may have or gain access to confidential data or 279 information owned or maintained by the other Party in the course of carrying out its responsibilities under the 280 contract. Vendor shall presume all information received from R1 or to which it gains access pursuant to the 281 contract is confidential. Vendor information, unless clearly marked as confidential and exempt from disclosure 282 under the Illinois Freedom of Information Act, shall be considered public. No confidential data collected, 283 maintained, or used in the course of performance of the contract shall be disseminated except as authorized by 284 law and with the written consent of the disclosing Party, either during the period of the contract or thereafter. 285 The receiving Party must return any and all data collected, maintained, created or used in the course of the 286 performance of the contract, in whatever form it is maintained, promptly at the end of the contract, or earlier at 287 288 the request of the disclosing Party, or notify the disclosing Party in writing of its destruction. The foregoing obligations shall not apply to confidential data or information lawfully in the receiving Party's possession prior to 289 its acquisition from the disclosing Party that were received in good faith from a third-party not subject to any 290 confidentiality obligation to the disclosing Party: that is now or later becomes publicly known through no breach 291 of confidentiality obligation by the receiving Party; or that is independently developed by the receiving Party 292 293 without the use or benefit of the disclosing Party's confidential information.
- 29415.USE AND OWNERSHIP: All work performed or supplies created by Vendor under the contract, whether written295documents or data, goods or deliverables of any kind, shall be deemed work-for-hire under copyright law and all296intellectual property and other laws. R1 does/does not waives its right to sole and exclusive ownership for all such297work, unless otherwise agreed in writing. Vendor acknowledges R1 may use the work product for any purpose.298Confidential data or information contained in such work shall be subject to the confidentiality provisions of the299contract.



- 300 16. **INDEMNIFICATION AND LIABILITY:** The Vendor shall indemnify and hold harmless R1, its agencies, officers, employees, agents and volunteers from any and all costs, demands, expenses, losses, claims, damages, liabilities, 301 302 settlements, and judgments, including in-house and contracted attorneys' fees and expenses, arising out of: (a) any breach or violation by Vendor of any of its certifications, representations, warranties, covenants or 303 agreements; (b) any actual or alleged death or injury to any person, damage to any real or personal property, or 304 305 any other damage or loss claimed to result in whole or in part from Vendor's negligent performance; (c) any act, activity or omission of Vendor or any of its employees, representatives, subcontractors or agents; or (d) any actual 306 or alleged claim that the services or goods provided under the contract infringe, misappropriate, or otherwise 307 violate any intellectual property (patent, copyright, trade secret, or trademark) rights of a third party. Neither 308 Party shall be liable for incidental, special, consequential, or punitive damages. 309
- **INSURANCE**: Vendor shall, at all times during the term of the contract and any renewals or extensions, maintain 310 17. and provide a Certificate of Insurance naming R1 as an additional insured for all required bonds and insurance. 311 Certificates may not be modified or canceled until at least thirty (30) days' notice has been provided to R1. Vendor 312 313 shall provide: (a) General Commercial Liability insurance in the amount of \$1,000,000 per occurrence (Combined Single Limit Bodily Injury and Property Damage) and \$2,000,000 Annual Aggregate; (b) Auto Liability, including 314 Hired Auto and Non-owned Auto (Combined Single Limit Bodily Injury and Property Damage), in the amount of 315 \$1,000,000 per occurrence; and (c) Worker's Compensation insurance in the amount required by law. Insurance 316 shall not limit Vendor's obligation to indemnify, defend, or settle any claims. 317
- 318**INDEPENDENT CONTRACTOR**: Vendor shall act as an independent contractor and not an agent or employee of, or319joint venturer with R1. All payments by R1 shall be made on that basis.
- SOLICITATION AND EMPLOYMENT: Vendor shall not employ any person employed by R1 during the term of the
 contract to perform any work under the contract. Vendor shall give notice immediately to the Agency's director if
 Vendor solicits or intends to solicit R1 employees to perform any work under the contract.
- BACKGROUND CHECK: Whenever R1 deems it reasonably necessary for security reasons, R1 may conduct, at its
 expense, criminal and driver history background checks of Vendor's and subcontractor's officers, employees or
 agents. Vendor or subcontractor shall immediately reassign any individual who, in the opinion of R1, does not pass
 the background checks.
- APPLICABLE LAW: The Vendor, its employees, agents, and subcontractors shall comply with all applicable Federal,
 State, and local laws, rules, ordinances, regulations, orders, Federal circulars and all license and permit
 requirements in the performance of the contract. Vendor shall be in compliance with applicable tax requirements
 and shall be current in payment of such taxes. Vendor shall obtain at its own expense, all licenses and permissions
 necessary for the performance of the contract. Furthermore, the contract shall be construed in accordance with
 and is subject to the laws and rules of R1.
