## **MPO RESOLUTION 2021-19**

RE:	INCLUSION OF ADDITIONAL MPO TECHNICAL COMMITTEE VOTING MEMBERS
WHEREAS	the Federal Highway Act of 1962, as amended, and the Urban Mass Transportation Act of 1964, as amended, provide for an urban transportation planning process; and
WHEREAS	the Fixing America's Surface Transportation (FAST) Act currently authorizes funding to improve our nation's transportation system for highways, highway safety, public transit, alternative non-motorized forms of transportation, and freight; and
WHEREAS	the Rockford Metropolitan Planning Organization (MPO) for the Rockford Metropolitan Area, and the MPO Policy Committee has the specific responsibility to direct and administer the 3-C (continuing, cooperative, comprehensive) urban transportation planning process; and
WHEREAS	the MPO Policy Committee has directed that MPO shall further engage in regional planning efforts on a wider and broader scale than previously seen; and
WHEREAS	the MPO Policy Committee has the authority to expanded or modify the MPO Technical Committee to include representation from transportation planning or implementing agencies with responsibility in the urban area, per the MPO Cooperative Agreement approved on August 18, 2018; and
WHEREAS	it is the desire of the MPO Policy Committee to expand the MPO Technical Committee membership to include one duly authorized representative from the Villages of Roscoe and Winnebago;

## NOW, THEREFORE, BE IT RESOLVED THAT:

The MPO Policy Committee hereby approves the expansion of the MPO Technical Committee for the inclusion of the Villages of Roscoe and Winnebago as members of the MPO Technical Committee, effective as of January 1, 2022, as shown in Attachment A.
