# 7) Approval of Budget

Mr. Dunn entertained a motion to approve budget, Winnebago County made a motion to approve, Belvidere seconded. Mr. Dunn explained the budget update for the year to date and next fiscal year's budget. Motion passed unanimously via roll call vote.

## 8) Approval of Closed Session Minutes

Mr. Dunn entertained a motion to approve closed session minutes. Belvidere made a motion to approve, Boone County seconded. Mr. Setter briefly explained why the closed session minutes are now okay to be released. Mr. Denzin explained why closed session was necessary and why it is allowed despite the Open Meetings Act. There is no pending transaction at this point and therefore no longer a need to keep closed session minutes confidential. Motion passed unanimously.

## 9) Staff Report

Mr. Setter updated the board on the possible development of home building in the Land Bank's area. A lack of new builds is a problem in many of the municipalities that are part of the land bank. Mr. Setter also brought up the closing of Home Start and how their closing creates a gap for housing counseling in the area. Many grants require there to be a housing counseling agency in the region to qualify. There is a possibility of R1 becoming a housing counselor so that the Land Bank's jurisdictions do not miss grant funding opportunities because of Home Start closing.

Mr. Setter then explained how Denzin's team will be providing some technical assistance in the identification of abandoned and tax delinquent properties. With the additional opportunities for acquiring properties, the land bank is looking to hire a certified inspector as part of its team to submit affidavits and evidence to streamline acquisition processes. Mr. Denzin then further explained the advantages of having a certified inspector on staff.

Mr. Dunn explained the ways in which various NILBA stakeholders are advocating for IHDA to fund land banks. Mr. Denzin then brought up the possibility of Lake County joining NILBA in some capacity; a discussion ensued.
