A RESOLUTION PROVIDING FOR THE ADOPTION OF A BUDGET FOR FISCAL YEAR 2019

WHEREAS, the Board of Commissioners of the Region 1 Joint Regional Planning Commission has made a comprehensive study and review of the proposed budget submitted by Executive Director Michael Dunn, Jr, and;

WHEREAS, it is the finding and conclusion of the Board that the anticipated revenues and expenditures for the 2019 fiscal year appear to be as accurate as possible for budgetary purposes.

Section 1. This resolution shall be known as the budget resolution for the Region 1 Joint Regional Planning Commission for the twelve (12) month period beginning July 1, 2018 and ending June 30, 2019.

The respective funds for each item of expenditure proposed in the budget for 2019 are hereby approved and adopted for the operation of the Region 1 Planning Council and constitute an appropriation of funds that are lawfully applicable to the items contained within the budget. This budget may be altered or revised by action of this governing body.
