Notice of Funding Opportunity Program Year 2023-2024

ROCKFORD, IL – The Winnebago County Community Mental Health Board (WCCMHB) has released a [Notice of Funding Opportunity](#) (NOFO) for Program Year 2023–2024 (PY24). WCCMHB is seeking proposals for the purpose of contracting with public or private entities for mental health and substance use services, including training and education for Winnebago County residents of all ages. The WCCMHB will prioritize innovative proposals that focus on target populations and that address priority areas, both of which are laid out in the updated [WCCMHB 3-Year Strategic Plan Updated Version November 2021](#).

The total funding available for Program Year 2023–2024 (PY24) will be up to \$20 Million. Those who are eligible to apply are not-for-profit corporations, for-profit businesses (properly licensed), hospitals and health care organizations, and other governmental entities and departments. Lead organizations that apply must be established for at least three years prior to applying for funding. Collaborative grant applications are highly encouraged. Non-traditional mental health organizations, especially those that provide services for underserved populations are encouraged to apply as collaborative partners with established service providers.

The WCCMHB is using a web-based grant platform, Foundant, for applications. The submission portal will be opened on December 12th, 2022, and will close on January 18th, 2023, at 5:00 P.M. CST and will be available on the [WCCMHB Funding Resources Page](#).

Emphasis will be placed upon the proposal's strength in addressing specific criteria within the electronic application. New applicants will first complete a brief abstract, and if accepted for application, a new "full" application may be submitted to be reviewed and scored by the board. Renewal applicants will complete an abbreviated application that will be reviewed and scored by the board.

Submission of an application does not guarantee approval or the award of funds. Grantee eligibility requirements must be met in full by all awarded grantee organizations.
