#### 1. Call to Order

#### 3. Action Item: Approve August 20, 2025 Meeting Minutes

**Motion** by Greater Rockford Chamber of Commerce, seconded by the Rockford Regional Health Council, to **approve** the August 20, 2025 meeting minutes.

Motion **approved** unanimously by voice vote.

#### 4. Action Item: Officer Nominations for Chair and Vice-Chair

Mr. Holcomb explained that nominations will be recommended to the R1 Governing Board, who will then approve the nominations for this advisory committee. Mr. Holcomb also explained duties of officers. Amanda Mehl was nominated for chair and Emily Klonicki was nominated for vice-chair. Nominations were approved by the committee through unanimous voice vote.

Officers will serve through June 2026, where they will then be renewed for a full term.

#### 5. Presentation: Community Data Summit

*Jillisa Bondurant, Alignment Rockford*

Jillisa briefly described Alignment Rockford's activity, specifically their work on the Early Development Instrument (EDI), which assesses children for kindergarten readiness. Data gathered by kindergarten teachers is then de-identified and overlaid on maps to provide context.

Alignment Rockford's Countywide Data Summit takes place on November 20. This event is a public presentation of the new Wave 3 of EDI data, followed by afternoon breakout sessions and a community discussion. Committee members received a flyer with additional details about the summit and encouraged to attend.

Discussion and questions followed.

## **6. Discussion: Northern Illinois Data Dashboard**

Isaac Guerrero, R1 Director of Economic Development & Policy, gave an update on the dashboard's contents and next steps. R1 staff is now adding education and workforce data points. This group was asked to suggest additional data points for this tool. Gina Caronna, Exec Director for TWC, provided a list of categories, including:

### **WORKFORCE**

- In-demand skills, identified by employers
- Educational attainment
- Largest industries
- Growing industries
- Age cohorts
- Total workforce availability and change in workforce (regional and county)
- Workforce by industry
- Labor participation rate

The committee suggested adding:

- Housing (individual metrics to include access, inventory, affordability, property tax for both rental and ownership; cost burden breakdown). It was commented that there may be enough information to make this category a separate dashboard tab.
- Health indicators
- Education (school districts)
- Safety
- Number of available seats in early education programs (to go on Education tab)

It was pointed out that these proposed metrics speak to separate audiences with separate needs, such as site selectors and individuals seeking to move into the area.

The R1 team and primary dashboard partners will continue building out the Workforce tab for committee feedback at the January meeting. The committee will also further discuss additional Education metrics for inclusion at the next meeting.

## **7. Discussion: Regional Health Atlas**

Mr. Holcomb announced that there is now a prototype of the health dashboard, found at [r1.metop.io](http://r1.metop.io). The committee was able to provide feedback on its contents.

Raegan Hilbrant gave a presentation on the regional Health Atlas, demonstrating how comparable municipalities use their atlases. This region's features a list of 87 indicators, sourced from Metopio's database. The committee was asked to provide feedback on the following questions:

1. Which indicators should be included for the public quick access (critical must-haves for your organization)?
  - a. Insurance source (public vs. private, providers)
2. Which local topics should be built out into separate tabs?
  - a. Committee members would like to talk to their clients to see what *their* priorities are in order to determine where the focus should lie
  - b. Provide examples of other datasets that universities and other organizations already provide that the atlas could include
  - c. Maternal health and youth wellness
  - d. Neighborhood equity
  - e. Housing quality + health connections
  - f. Kids + DV survivors. Efficacy in child protection or recidivism rate. How schools are increasing protective factors for kids. There is a concern with the county supporting making this data publicly available.
3. Are there local datasets you have access to that you would like R1 to explore for inclusion?
  - a. Urban Institute overall access to healthcare vs. poverty level
  - b. Family Peace Center domestic violence
  - c. Data USA
  - d. Something through NIU
  - e. Assessing housing structure quality, vacant lot status

# Regional Health Atlas Indicator Recommendations

The Regional Health Atlas was presented to the Regional Data Advisory Council (RDAC) during the meeting on 10/29/2025. Feedback on indicators was collected during the meeting and welcomed from 11/6/2025 to 11/17/2025. The Regional Health Atlas was also presented to the Rockford Regional Health Council (RRHC) on 11/5/2025 and solicited feedback on indicators from 11/5/2025 to 11/18/2025.

Feedback from RDAC members was reviewed, as well as Boone and Winnebago Counties' Illinois Project for Local Needs (IPLAN) and local health systems' Community Health Needs Assessments (CHNA), and compiled a list of proposed indicators for the Health Atlas.

Boone County's 2023-2027 IPLAN identified the following three priorities as its focus: behavioral health, maternal and child health, and food security.

Winnebago County's 2025-2030 IPLAN identified the following three priorities as its focus: maternal and child health, mental and behavioral health, and violence.

The overlap of behavioral health and maternal and child health indicates these are two of the most relevant health issues in our area. It is important to select indicators related to these topics, as two county health departments received community input that led them to establish similar priorities.

OSF Saint Anthony Medical Center 2025 CHNA identified two health priorities for the coming year, mental health including substance use and healthy behaviors – preventative health.

MercyHealth Javon Bea Hospital– Riverside 2023 CHNA indicated their priorities as: chronic diseases; nutrition, physical activity, and obesity; and maternal, infant, and child health.

UW Health SwedishAmerican Hospital and UW Health Belvidere Hospital identified the following priorities in their 2025-2028 CHNA: chronic disease prevention and management; access, community



well-being & social support; mental health and substance use; and health literacy and trust in health care.

Overlapping priorities found in various CHNA reports are mental health and substance use and chronic disease prevention (including preventative health).

All proposed topics were cross-checked in Metopio to ensure data was existent, up-to-date, and thorough. If RDAC and RRHC member organizations do not see an indicator that was picked as relevant, it is likely due to the indicator being similar to another previously vetted indicator or the data was deemed insufficient.

Following a soft-launch of the Regional Health Atlas at community events like Alignment Rockford's Data Summit on November 20<sup>th</sup>, 2025 and Region 1 Planning Council's Community Action Forum on December 11th, 2025, select indicators were identified as out-of-date, missing, or not ideal for use in the Health Atlas. Region 1 Planning worked with Metopio to identify alternative indicators for those

Thus, the following indicators are recommended for publication on the Health Atlas, focusing on behavioral/mental health and substance use, maternal and child health, and preventative health and chronic disease.
