

Public Transit, Now Serving Rural Winnebago County



As of July 1, rural Winnebago County residents can take public transit right from their front door. For those without reliable transportation, this new service opens up access to employment, healthcare, education, and independence.

to destinations within the county or to the Rockford Mass Transit District's West State St. station with free transfers between systems. Reagan MTD is the public transit service provider for Lee and Ogle counties; Winnebago County routes are an extension of their services.

Users must book a ride at least 24 hours in advance by calling 815-288-2117. Hours of operation are Monday – Friday from 6:00 am – 6:00 pm. There is a small fee for service and all vehicles are handicap-accessible. See https://reaganmasstransit.org for full pricing and other information.

NILBA Allocated State Funding in 2026 Illinois Budget



Land banks provide value in reducing blight, increasing tax revenue, and transforming neighborhoods. Illinois state legislators showed their support for land banks by including dedicated funding in the 2026 state budget. The Northern Illinois Land Bank Authority (NILBA) is set to receive \$2 million through the Department of Commerce and Economic Opportunity (DCEO). Other state land banks receiving funds include the Peoria Land Bank and South Suburban Land Bank and Development Authority.

NILBA will use this funding to scale up its successful work: reducing blight and increasing housing availability. Since its formation in 2019, the Northern Illinois Land Bank Authority has been responsible for returning nearly \$30 million in property value to the tax base and continues to expand its service area.

R1 is grateful for advocacy in Springfield from Senator Stadelman and Representatives West and Vella, who helped make this funding possible.

Help Your Community Plan for EV Charging Stations



Electric vehicle (EV) adoption is increasing rapidly throughout Northern Illinois. Vehicle registrations increased 40 percent in July, compared to a year ago across Winnebago, Boone, McHenry, Stephenson and Ogle Counties.

Does your community have vehicle charging stations to accommodate drivers' shifting habits? What is the best site for EV charging stations? What type of infrastructure do you need to support them?

R1 offers free technical assistance to help your city, village or county determine: 1) Optimal locations for EV charging stations; 2) Site-specific infrastructure that's needed to support charging stations; 3) Zoning, permitting and other regulatory considerations; and 4) Available grants and funding opportunities.
