C) Public Comment

1) Dr. Rhonda Verzal, UICOMR

- Dr. Verzal, Director of UICOMR Family Medicine Residency Program, explained the multiplier effect on this program through the Board's funding. The program has enhanced skills taught in its 3-year residency program by adding care for patients with substance or opioid use disorder. The Family Medicine Resident Program has also received a Street Medicine grant that will provide a resident and faculty physician to provide care in the community for addiction and mental health services for the next five years. She also highlighted students and staff who have joined the team or pursued additional addiction medicine certifications. Impact will be significant grant to provide resident and faculty person in the community providing addiction, mental health, and substance use services for next 5 years.

E) Monthly Activity Report – October 2025

1) Jason Holcomb, WCCMHB Director, gave the October 2025 Activity Report.

- Mr. Holcomb mentioned the Health Atlas is currently in development. Data for the Health Atlas is provided by Metopio and curated with input from community organizations. There will be a presentation at a future meeting.
- Mr. Holcomb also gave an update on the Board's strategic planning process. Organizations providing mental health or substance use services that are currently not receiving funding from the Mental Health Board are being surveyed. The public participation survey will be distributed by the end of the month, with local data collection taking place through the end of 2025.
- Mr. Holcomb reported that key informant interviews will be used to explore the CCBHC hub and spoke model, as the WCCMHB considers adopting this conceptual framework. Specifically, these interviews will explore funding sources and gaps within this model and what collaboration looks like among multiple agencies.
- Mr. Holcomb promoted the Growing Up Strong data summit taking place in two weeks. Alignment Rockford will present their recent EDI results. Mr. Holcomb will also present on the Health Atlas and encouraged Board members to attend.
