MPO Technical Committee Meeting

Meeting Minutes

Thursday, January 22, 2026 10:00 am

1) Call to Order

The meeting was called to order by Tim Verbeke at 10:00 am.

2) Roll Call

3) Public Comment

No public comments were brought forward at this time.

4) Discussion Items:

a) Preliminary Scoring of Attributable Funds (STBG, TAP, CRP)- Mr. Verbeke explained that R1 staff scored submissions based on previously approved policies. Funding has been made available for almost all projects. For STBG 4 projects (which scored over 75, and based on percentage of overall scores. The team took averages and assigned percentages to qualifying projects. Member asked if future allocation will increase effective amounts, Verbeke said potentially, but that would require another call for projects. Member asked if underfunded amounts will effect future request's scoring, Verbeke indicated that was a possibility. Mr. Verbeke went on to explain that all TAP requests would be fully funded, based on estimated projections and potentially lapsing funds would be used. Carbon Reduction projects are fully funded in the rear requested. Members posed questions to which Mr. Verbeke indicated he would follow-up about parameters individually. Mr. Verbeke closed by explaining that the projects would go before the Policy committee the following week.

b) Traffic Signal Coordination and Timing Study-Eric Tison announced that the Traffic Signal Coordination and Timing is entering its 3rd and final phase of the project entering into a contract with ITERIS consulting to provide assessment and recommendations for the Perryville Road corridor from Harrison Avenue to Swanson Road and will include 35 intersections within a 1/3 mile of Perryville. He then indicated that each jurisdiction would stay informed in process, which will start within the next 4 weeks. The final draft is expected to be delivered around Memorial Day. Mr. Tison and Mr. Verbeke explained that the choice of location came about due to robust internal discussion about extending the work already completed and the cross-over of several jurisdictional boundaries, allowing for a variety of partners.

5) Action Items:

a) Approval of the October 30, 2025 Meeting Minutes

Mr. Verbeke called for the approval of the 10/30/2025 meeting minutes. Ms. Mandujano, Village of Machesney Park, Community Development motioned, seconded by Mr. Molina, Winnebago County Highway Department. With no further discussion, motion passed by unanimous voice vote.

b) Adoption of the Federally -Required performance Management Targets (Resolution 2026-01) Mr. Brandon Rucker explained a focus on Safety Standard PM1 and the Safety Action Plan, which looks at fatality rates, serious injury and non-motorized vehicle rates. Information included is IDOT 5 year rolling averages, showing a steady decline. New targets are included in the packet. Rounding worked out the same between 26 & 27. Targets are dropping slightly with an annual reduction of 2 %. RMTD adopted targets updated at their last board meeting. Mr. Verbeke called for a motion. Mr. Capovilla, City of Rockford, motioned, seconded by Mr. Egelkes, RMTD, vote passed by unanimous voice vote.

6) Staff Reports-

- **Bicycle and Pedestrian Safety Grant**- Ms. Chloe Barnes announced that R1 has been awarded a Bicycle and Pedestrian Safety Grant. The \$500K award will support educational safety programs targeting elementary students. R1 will acquire the services of a consultant to analyze school zone safety, and measure commute routes to and from schools. Work will include parent surveys and public engagement strategies. Work is expected to kick-off in February 2026 and go through October 2027. Services will also include virtual training for crossing guards.
- **Passenger Rail Design**- Mr. Verbeke gave an update that R1 has been working on behalf of the Winnebago County Rail Authority on a FRA grant to support design and engineering for the Rockford and Belvidere passenger rail stations. R1 staff is also assisting the village of Roscoe and Winnebago County with a BUILD Grant for the Love RD (North of McCurry), funding up to \$17 million available.
- **Reconnecting Communities (SW Railyard)**-Mr. Tison updated members that AECOM is working to reach scenario planning stage, existing conditions report for 34 acre area. They are assessing challenges within the site, how development can occur, which will lead to a public engagement presentation. Timing is uncertain, but looking to be done before the end of summer.
- **2026 Update timeline**: April: project approval and TIP software training; June: Approving TIP, FTAS, EV Readiness; July: Traffic Signal Management-Perryville project conclusion; September: Livable Communities Initiative; October-Safe Streets for All final approvals.
- **Other**: R1 staff are engaging in more speaking engagements at the national level, and most recently have spoken with congressmen about the reauthorization of STBG funds. Mr. Dunn and Chairman Chiarelli traveling

to DC next week. Mr. Verbeke has been added to the AMPO Technical Committee and will be speaking at the February Safe Road summit, speaking on LCI. In April, Ms. Barnes and Mr. Verbeke will be traveling to Kentucky to speak on the Bicycle & Pedestrian Safety grant.

- **New Staff:** Mr. Verbeke then introduced new staff and interns to members.

MPO RESOLUTION 2026-02**

- RE:** **Amendment to the Fiscal Year 2026-2029 Transportation Improvement Program**
- WHEREAS** the Federal Highway Act of 1962, as amended, and the Urban Mass Transportation Act of 1964, as amended, provide for an urban transportation planning process; and
- WHEREAS** the Infrastructure Investment and Jobs Act (IIJA) currently authorizes funding to improve our nation's transportation system for highways, highway safety, public transit, alternative non-motorized forms of transportation, and freight; and
- WHEREAS** the IIJA Act and its predecessors, require a Long-Range Transportation Plan (LRTP) as well as a Transportation Improvement Program (TIP); and
- WHEREAS** the Region 1 Planning Council is the Metropolitan Planning Organization (MPO) for the Rockford Urban and Metropolitan Area, and the MPO Policy Committee has the specific responsibility to direct and administer the continuing urban transportation planning process; and
- WHEREAS** the MPO Policy Committee has adopted the June 20, 2025 version of the Fiscal Year 2026-2029 Transportation Improvement Program (TIP) and;
- WHEREAS** the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have approved the FY 2026-2029 MPO TIP; and
- WHEREAS** the Illinois Department of Transportation has requested the addition of four (4) new projects;
- WHEREAS** the Village of Machesney Park has requested the addition of one (1) new project;
- WHEREAS** the projects being amended in the adopted and approved version of the FY 2026-2029 TIP will not affect or impact the other projects listed in the FY 2026-2029 MPO TIP; and
- WHEREAS** the MPO Technical Committee has recommended the adoption of the TIP amendment by the MPO Policy Committee; and

NOW, THEREFORE, BE IT RESOLVED THAT:

The MPO Policy Committee hereby amends the FY 2026-2029 MPO Transportation Improvement Program to include the projects listed in "Attachment A".
