

# Fighting Blight in 6 Counties Land Bank Extends Service Area to include Lake County



#### Northern Illinois Land Bank Authority (NILBA) added Lake County to its service area.

NILBA now serves six counties in northern Illinois: Stephenson, WInnebago, Boone, McHenry, Ogle, and Lake.

Under this partnership, Lake County Land Bank Authority will refer suitable properties to NILBA, whose staff of four will take care of all the other tasks necessary to clear property liabilities and resell. Leaning on NILBA's expertise is more efficient for Lake County and expands the impact that both organizations make in neighborhood revitalization.

NILBA has a history of success in fighting blight; acquiring and selling 44 properties for nearly \$1.5 million in sales since its start in 2019. Its involvement in repurposing vacant properties has converted distressed neighborhoods into safer, attractive ones providing a higher quality of life for all residents.

## **LCI Now Taking Applications for Round 2**

The second round of the Livable Communities Initiative (LCI) is now open! Neighborhoods can apply for technical assistance from R1 to draw up a plan to increase their quality of life. Selected communities will later become eligible for implementation funding.

# First Clean Energy Training Graduates Certified for Good-Paying, Lasting Careers

For some residents in Rockford's disadvantaged communities, getting a good-paying, lasting career seems out of reach. In just months, 20 of those individuals are now looking for careers - not just going from job to job - after graduating from Climate and Equitable Jobs Act (CEJA) workforce training in May.

They are the first completed cohorts in the Rockford hub's CEJA workforce development program. Graduates chose their career path from the following programs:

Organization	Graduates	Certification
Awaken Foundation L3c	7	Weatherization/Clean Construction
Zion West Enterprise	9	Solar Panel Installation
Rock Valley College	4	<b>CNC Machinery Operation</b>

CEJA is not your typical workforce development initiative. Focusing on underserved neighborhoods, it offers free instruction and by giving stipends for completing major course milestones, actually pays students to train. Supports for barriers like transportation or childcare are provided and participants receive a dedicated case manager to help at every step along the way, from registration to resume preparation. It also broadens the regional economy by preparing workers to fill the additional jobs that will provide the state with 100% clean energy by 2050.

A new training cohort begins every 12 weeks, with the next expected in early fall. You can help

by spreading the word on how transformational this program is for participants and the companies that have hired them.

Distributed quarterly, this anonymous survey is designed to capture the attitudes, behaviors, and demographics of Rockford region businesses. Data will then be used to determine trends and identify economic development opportunities. This will make our region more competitive for businesses looking to locate or expand here, hire talent, and more.

First quarter results were overwhelmingly positive:

- 56.7% of business owners felt their business is healthy.
- 88.2% will invest the same or more in their business in the coming year.
- · 45% plan to increase staff in the coming year.
- The availability of a skilled workforce is the biggest barrier to growth.

The survey will be open from June 2 - 15.
