Re: Update to the Rockford Region's Functional Classification System

Region 1 Planning Council (R1) would like to request an update to the region's Functional Classification System on behalf of our partner organizations. Since the time of the last system wide update in 2021 to the Functional Classification System for Boone, Winnebago, and Ogle Counties within the R1 Metropolitan Planning Area (MPA), there is a pending construction project that will warrant an update to the functional classification of a roadway in downtown Rockford. This project is the two-way conversion of Church Street and Main Street. R1 has coordinated with the appropriate local and regional agencies that have jurisdiction over the roadways for this proposed change to the Functional Classification System.

Two-Way Conversion of Church Street and Main Street

Currently, Church Street and Main Street are constructed as one-way pairs with traffic moving in a southerly direction on Church Street and traffic moving in a northerly direction on North Main Street. This one-way pair serves as Illinois Route 2 and is a north—south state highway in northern Illinois. Illinois Route 2 currently starts at Illinois Route 40 in Sterling and terminates at the Wisconsin state line in South Beloit. Both Church Street and Main Street are the only one-way sections of Illinois Route 2 in the State. Once completed, both Church and Main Street will service both northern and southern vehicular travel movements. The Illinois Route 2 designation and ownership will remain on Church Street while North Main Street will receive a jurisdictional transfer and be awarded to the City of Rockford. Both roadways are currently under the ownership of the Illinois Department of Transportation (IDOT).

3. Public Comment

There were none present who wished to address the committee.

4. Discussion Items

a. 2025 Metropolitan Transportation Plan (MTP) Update

Ms. Turner presented an overview of the MTP, focusing on the plan's regional assessment. Ms. Turner requested members to share projects related to connectivity & accessibility, maintenance & operations, traffic safety, funding considerations, economic vitality, balanced development, and quality of life. Discussion was held on existing and planned transportation projects, programs, policies, and current barriers in the region that could be highlighted in the MTP.

b. Regional Traffic Safety Action Plan – Goals & Emphasis Areas

Ms. Turner provided an update on the vision, mission, and objectives for the Regional Traffic Safety Action Plan. The objectives will be updated to align with the MTP and adopted traffic safety targets. The Regional Traffic Safety Action Plan Engage R1 survey was highlighted to share the community's traffic safety concerns; as of May 23rd the survey has received 51 responses.

Ms. Turner facilitated an activity using Mentimeter to gain stakeholder input on the project's goals and emphasis areas. This feedback will be used in coordination with regional data to create priority emphasis areas to identify safety improvement strategies. The Mentimeter results indicate that speeding and aggressive driving were voted as the two biggest concerns related to traffic safety behavior in the region; pedestrians were voted as the top priority for safer road users; intersections were voted as the highest safer road concern; and the overall largest traffic safety concerns for the region were distracted driving and speeding.

5. Action Items

a. Approval of the Meeting Minutes of March 21, 2024

Ms. Turner entertained a motion to approve the Meeting Minutes of the March 21, 2024 MPO Technical Committee.

Motion by Mr. Anderson, City of Belvidere, Public Works Department, and seconded by Mr. Molina, Winnebago County Highway Department with the amendment to change "Elevator Road" to "Bell School Road" to approve the March 21, 2024 Meeting Minutes. Motion approved by unanimous voice vote.

b. Amendment to the FY 2024-2027 Transportation Improvement Program (Resolution 2024-07)

Mr. Larsen reported that the MPO had received several amendment requests for requested the addition three (3) updated cost breakout and the addition of seven (7) new projects into the FY 2024-2027 Transportation Improvement Program. These projects included:

- 1-21-11: IL 173, from 0.4 mile east of Lyford Road to 0.1 mile west of Winnebago County Line (Updated Cost Breakout)
- 2-24-1: Riverside Boulevard, from Material Avenue to Renn Hart Hills Road/Sage Road (*Updated Cost Breakout*)
- 2-24-5: Riverside Boulevard, from Material Avenue to Renn Hart Hills Road/Sage Road (New Project Phase)
- 7-23-4: Low/No Application, Replacement Buses 7 Hybrids Buses (Updated Cost Breakout)
- 7-24-1: Low/No Application, Replacement Buses 4 Hybrids Buses (New Project)
- 7-24-2: 520 Mulberry Renovation Construction, Renovation of older building to make space more efficient (*New Project*)
- 7-24-3: 520 Mulberry Renovation Furniture and Equipment, Renovation of older building to make space more efficient (New Project)



- 7-24-4: 520 Mulberry Renovation A&E, Renovation of older building to make space more efficient (New Project)
- 7-24-7: Demand Response Vehicle, Replacement Vehicles 4 Medium Duty Demand Response Vehicles (New Project)
- 26-24-1: Demand Response Vehicle, Replacement Vehicles 3 Medium Duty Demand Response Vehicles (New Project)

Motion by Mr. Krohn, Boone County Highway Department, seconded by Mr. Anderson, Belvidere Public Works Department to recommend Resolution 2024-07 for adoption.

RMTD requested an amendment Resolution 2024-07 that would to reduce the 5310 award to RMTD from four (4) demand-response vehicles to three (3) vehicles (TIP #7-24-7) and increase the 5310 award to Boone County Transportation from three (3) demand-response vehicles to four (4) vehicles (TIP #26-24-1).

Motion by Ms. Hughes, Rockford Mass Transit District, seconded by Mr. Messinger, City of Loves Park, Public Works Department to amend Resolution 2024-07 with the aforementioned updates to transit projects #7-24-7 and #26-24-1 and recommend it for adoption by the MPO Policy Committee. Motion approved by unanimous voice vote.

c. Adoption of the Complete Streets Standards Guide (Resolution 2024-08)

Ms. Turner provided a description of the Complete Streets Standards Guide and the associated Policy, that was adopted in January. The purposed of the Standard Guide is to identify and describe the design and structure of complete streets in the region. No comment was received during the document's public comment period.

Discussion was held on annual MPO requirements under the Bipartisan Infrastructure Law and restrictions compared to state guidelines.

Motion by Ms. Mandujano, Village of Machesney Park, Community Development Department, and seconded by Mr. Belle, City of Rockford, Community Development Department to recommend the adoption of the Complete Streets Standards Guide. Motion <u>approved</u> by unanimous voice vote.

6. Staff Reports

Ms. Turner reported that the next MPO Technical and Policy Committee meetings will discuss the new Metropolitan Planning Area boundaries before going to IDOT for review. The MPA updates are based on the Urbanized Areas as defined in the 2020 Census. Additionally, the next MPO Technical Committee meeting will present an item related to a functional classification change request for a jurisdictional transfer between IDOT and City of Rockford for concurrence from the committee.

7. Agency Reports

a. Boone County, Highway Department

Mr. Krohn reported that Boone County Highway Department's road resurfacing and replacement program has started and will occur over the next few months.

b. Boone County Conservation District

No report.

c. Chicago Rockford International Airport

No report.

d. City of Belvidere, Public Works Department

No report.

e. City of Loves Park, Public Works Department

Mr. Messinger reported that the City's Evans Avenue Reconstruction water main work is complete. Additionally, the City's storm sewer work and other 2024 projects have begun.

f. City of Rockford, Community Development Department

Mr. Belle reported that last month the City of Rockford adopted a housing needs assessment market study.

g. City of Rockford, Public Works Department

Mr. Carter reported that in the first week of June the City of Rockford, with support from the IDOT, will begin a pilot program to reduce the roundabout on Main Street and Auburn Street to one lane as a means of reducing



the frequency of accidents. The pilot program will last one year before a final decision is made to maintain one lane or revert to its original two lanes.

h. Four River Sanitation District

No report.

i. IDOT, District 2

No report.

j. Rockford Mass Transit District

Ms. Hughes reported they had received 14 demand-response vehicles, which are all on the road right now. There has been a delay on 4 hybrid vehicles due to supply chain issues.

k. Rockford Park District

Mr. Bragg reported that on Friday May 31st there will be a grand opening for Levings Lake Unity Pavilion. Additionally, RPD is hosting a Sunday music series and a Thursday summer music series. The Lockwood Indoor Equine Center is under construction to begin a youth equine-assisted therapy program.

I. Village of Machesney Park, Community Development Department

No report.

m. Village of Roscoe

Mr. Kurlinkus reported that the Village is starting its annual residential streets resurfacing program at the end of June, which is scheduled to last three weeks.

n. Winnebago County, Community & Economic Development Department

No report.

o. Winnebago County, Highway Department

Mr. Molina reported that the Riverside STBG project has started Phase II right-of-way acquisition. Funds will be used for local material and storm sewer over the next 3 months. Elevator Road construction, resurfacing and widening, will start on June 3. Linden Road, east of Alpine Road, opened bids a week ago and will hopefully be awarded by the County Board on May 23. Perryville Road Path construction, north of Anjali Way, has taken place over the past 3 weeks and should be completed soon. Bell School Road project is making progress with no delays anticipated. The Water Main Extension project on Baxter Road will start within the next 2 weeks.

p. Boone County Council on Aging

q. FHWA, Illinois Division

Jon Paul Diipla introduced himself as the new FHWA contact for the Rockford MPO. Mr. Diipla reported that the Safe Streets for All grant applications for demonstration grants are due on August 29, 2024 and Active Transportation Investment Program grant applications are due on June 17, 2024.

distributed to the public in accordance with federal guidelines and with the MPO Public

Participation Process; and

WHEREAS the draft document was made available for public comment between April 1, 2024 and April 30,

2024, and no comments were received from the public; and

WHEREAS the MPO Technical Committee has reviewed the FY 2025 Unified Work Program (June 28, 2024

version) and recommends approval;

NOW, THEREFORE, BE IT RESOLVED

That the MPO Policy Committee:

- 1. Adopts the FY 2025 Unified Work Program (June 28, 2024 version);
- Certifies that the Rockford MPO transportation planning process is in compliance with all Federal requirements and is being carried out in accordance with all applicable provisions as specified in the Intergovernmental Agreement with the State of Illinois, Department of Transportation;
- 3. Directs the MPO Director to submit the FY 2025 Unified Work Program (June 28, 2024 version) and this Resolution to the State of Illinois, the FHWA and the FTA;
- 4. Directs R1 Executive Director to pursue and enter into an Intergovernmental Agreement with the State of Illinois for the purpose of funding and conducting the activities set forth by the Unified Work Program; and
- 5. Directs R1 Executive Director to pursue and enter into contracts with professional consultants, as needed, for the purpose of carrying out various sub-elements of work as specified in the Unified Work Program.

WHEREAS the AUA and MPA are needed for the development of planning activities for the Rockford Region

within the Metropolitan Transportation Plan (MTP), Transportation Improvement Program (TIP),

and other MPO related documents as required by the current transportation law; and

WHEREAS the AUA and MPA are needed to define areas in which urban transportation funding (i.e., Surface

Transportation Block Grant, etc.) can be allocated within the Rockford planning area; and

WHEREAS adjustments to the AUA and the MPA have been presented to the MPO Technical Committee,

which has reviewed the suggested MPA adjustments, concurs that this area has the potential to development within the next 20 years, and recommended approval of the new 2020 MPA to the

MPO Policy Committee, as depicted in Exhibit 1; and

WHEREAS the MPO Policy Committee has inspected the AUA and MPA as attached in Exhibit 1;

NOW, THEREFORE, BE IT RESOLVED

the MPO Policy Committee adopts the Adjusted Urbanized Area (dated 06/28/2024) and the

Metropolitan Planning Area (dated 06/28/2024) as depicted in Exhibit 1;

AND BE IT FURTHER RESOLVED





WHEREAS	the Region 1 Planning Council is the Metropolitan Planning Organization (MPO) for the Rockford Urban and Metropolitan Area, and the MPO Policy Committee has the specific responsibility to direct and administer the continuing urban transportation planning process: and
WHEREAS	the MPO Policy Committee has adopted the June 30, 2023 version of the Fiscal Year 2024-2027 Transportation Improvement Program (TIP) and;
