a. ***Housing Counselor Introduction***

Jimmy Westenberg is the new Housing Counselor and gave an overview of his position at R1.

b. ***Housing Scenario Planning – Activity***

Ellie Sander, R1, gave an overview of the Housing Coordination Plan that R1 is developing. Ms. Sander also asked the group to provide suggestions for additional demographic groups that R1 should consider including in focus groups in order to ensure a good representation of feedback.

Eric Tison, R1 Project Coordinator, gave a presentation on the YEP! (Youth Engagement in Planning) initiative. YEP! Meets with RPS 205 high school students to complete hands-on activities involving urban planning in order to introduce it as a career option. Megan Devine and Nathan Larsen, both part of the R1 YEP! team, led the group through an activity of discussion questions exploring housing and perceptions around it. The group then ranked various housing types based on desirability and community need.

a. ***RMTD Notifications of Service Updates***

RMTD Representatives: Erick Groshans, Transit Operations Planner, and Orlando Toatley, Marketing & Communications Manager, informed the group of changes it is implementing beginning September 1. It will increase frequency, add an additional hour of service, and add stops for specified routes. This provides additional coverage in response to user demand.
