Solar Lights Up Rockford First Regional Solar Expo Draws Strong Support

Local support for solar energy shone strong at the region's first Solar Conference & Expo, hosted by Sustain Rockford on July 18 at the Embassy Suites Rockford Riverfront Hotel.

Sustain Rockford is a nonprofit organization that champions solar energy production and other sustainable efforts to preserve the region's land, water, and air. Region 1 was a sponsor and helped plan the event, which drew more than 200 attendees, speakers, and exhibitors.

"At Sustain Rockford, we feel a strong sense of urgency to ramp up our region's sustainability," says Brad Roos, president of Sustain Rockford. "Solar has never been cheaper, the financial incentives have never been greater, and the need has never been more clear. The glass is, indeed, half full."

Attendees participated in expert-led sessions, getting insights into emerging trends and financial incentives for solar developments. Speakers and breakout sessions included information for all key stakeholders, including residential consumers, businesses, and the broader public sector. Additionally, more than a dozen companies and organizations displayed their services at the conference's vendor expo.



Traffic Safety Action Plans Under Development



Serious injuries and fatalities on U.S. roads have steadily increased over the past decade, spiking in recent years. The Rockford region is no different.

R1 wants everyone on the roadways - riding, walking, biking - to arrive at their destination safely. This is why R1 is creating four traffic safety action plans that aim to reduce or eliminate serious vehicle crashes, with support from the U.S. Department of Transportation's Safe Streets and Roads for All program. The Regional Traffic Safety Action Plan is comprehensive for the entire Rockford region. R1 is also developing plans for the City of Rockford, Boone County, and Winnebago County in coordination with their respective jurisdictions. This allows each jurisdiction to determine goals and strategies appropriate for their unique situations. Developing four separate plans also provides more opportunities for implementation funds to be distributed, including rural areas not in R1's coverage area.

Each of these safety action plans will:

- 1. Develop a comprehensive understanding of the state of traffic safety in that area
- 2. Identify local and regional trends through extensive data analysis

- 3. Establish a vision, goals, and strategies to significantly reduce or eliminate fatalities and serious injuries
- 4. Create a framework for activities that can be implemented to improve traffic safety.

The plans have completed several rounds of public feedback, involving the public, local traffic safety stakeholders, and each plan's steering committee. All four plans are wrapping up the data analysis process and will then begin to identify strategies for reducing and eliminating crashes that result in severe injuries or fatalities.

Employee Spotlight






