OLD BUSINESS

a) Control Monument Inventory

As referenced in the document that was sent in advance of the meeting, the WinGIS staff (Steven Gregg, Sarah Stromberg and Aaron Frey) scored the quotes from 6 agencies and selected Ayres & Associates to conduct our Control Monument Inventory project.

b) Comprehensive Layers Map

As there have been a few people indicating there is a need for a map with a combination of layers that appear in the Property Search, Utility and the former 911 maps as well as a few various other layers coupled with the fact that the old Main Map uses a web service still on an old server, WinGIS will create a Comprehensive Layers map to serve as a replacement for the old "Main Map". Additionally, Mr. Gregg reminded the group that a Comprehensive Layers map already exists in the WinGIS Portal for those that have logins.

NEW BUSINESS

a) Editing Related tables in Portal

WinGIS recently created a hydrant flushing app for the city of Loves Park utilizing functionality that became available with the Enterprise Upgrade performed last year (with assistance from CloudPoint Geospatial). It allows users to not only edit geometry and attribute data, but also related table data, from a web map application.

b) 911 Update

Sarah reported the since WinGIS has remote access to the 911 servers, she has been able to work with Curtis from Central Square to continue training, documenting the process to update the new 911

system, scheduled to go live in August. Additionally, all of our data has been sent to the State of Illinois as part of the other 911 upgrade taking place, looking to standardize 911 data formats.
