Proposals Requested for Four Redevelopment Opportunities

Rockford, IL – Region 1 Planning Council (RPC) is requesting proposals for four development opportunities within the City of Rockford. One is a large commercial property and three are large vacant lots.

As agent of the Winnebago County Trustee program, the Region 1 Planning Council is looking for interested parties for the **redevelopment of the vacant industrial structure located at 620 Buckbee Street, Rockford, IL**. This property is zoned as light Industrial, is a 1.18 acre parcel industrial building in Rockford's Southeast side, with 51,000 square feet. Additionally, this property is located in a River Edge Redevelopment Zone, part of the Broadway TIF (expires 2032), in an Opportunity Zone, and is New Market eligible.

Region 1 Planning Council also houses the Northern Illinois Land Bank Authority, which is seeking proposals for the development of three large vacant lots:

730 Lincoln Park Blvd, Rockford, IL

1306 S Court St, Rockford, IL

602 14th St, Rockford, IL

These properties are former school building sites within the RPS 205 School District. All structures on the properties were demolished, leaving large vacant properties. These properties were donated by RPS 205 to the Land Bank in late 2020.

Region 1 Planning Council, through the Winnebago County Trustee and the Northern Illinois Land Bank Authority, is continuously working to revitalize neighborhoods and communities in the region. Between the two programs, the RPC has assisted with the redevelopment of over 400 parcels in the region.
