1) Call to Order

With a quorum present, the meeting was called to order by Mayor Jury at 7:35 am.

2) Roll Call

3) Public Comment

There were none present who wished to address the Committee.

4) Consent Agenda

a) Approval of April 29, 2022, Meeting Minutes

Motion by City of Rockford, seconded by Winnebago County, to approve the Consent Agenda. Motion unanimously **approved** by voice vote.

5) Action: Approval of RFQ: Payroll & Accounting Services Award

Mr. Dunn and Ms. Halsted presented a recommendation to contract with Lauterbach & Amen for payroll and accounting services beginning FY2023.

Motion by Boone County, **seconded** by City of Belvidere, to approve the award of RFQ: Payroll & Accounting Services. Motion unanimously **approved** by voice vote.
