1. Call to Order

With a quorum present, the meeting was called to order by Ms. Turner at 10:00 am.

3. Public Comment

4. Discussion Item:

Bicycle & Pedestrian Planning

Ms. Ribikawskis delivered a presentation on program goals and objectives. Ms. Turner clarified that Objective 3.2, Livable Communities Forum is established, and Objective 3.6, Complete Streets is now federally required and part of the UWP for both policy and design standards. Staff requested that comment form be completed and returned.

Resolution 2023-02 is an amendment to the FY 2023 – 2026 TIP. The following amendments have been requested: IDOT requested a project be moved fiscal years and cost breakouts updated; City of Rockford requested four projects be moved between fiscal years, thirteen projects updated with new cost breakouts and nine additional new projects.

6. Staff Reports

6.1 SPR Project Updates

- a. **Freight Study:** Ms. Turner reported that data had been received allowing the draft plan narrative to be completed. The study is now in final phase development and should be available for review by April. Mr. Geber added that the state study is also nearing completion, but perhaps not on the same timeline.
- b. **Keith Creek Corridor Study:** Mr. Tison reported the Keith Creek report has been completed and is posted to the R1 website. He invited the members to review the report if they have not already done so.
- c. **Passenger Rail Station Siting Analysis:** Mr. Tison reported that the final draft of siting analysis has gone through review by R1 staff and City of Belvidere staff. The final draft is expected for review at the next meeting.
- d. Regional Traffic Signal Management Program: Ms. Ribikawskis reported that an RFP for consulting services was released and posted to DemandStar. It was requested that Steering Committee members stay for a brief update as questions from interested parties have been posed.

6.2 Advanced Construction Notices

Ms. Ribikawskis informed the committee of advanced construction notices received from the Illinois Department of Transportation.

- #1-23-18: Districtwide bridge preservation in Boone County
- #1-23-19: Districtwide bridge preservation
- #1-23-5: Downtown Rockford Complete Streets Revitalization from Avon Street to Kishwaukee Street (IL 251)
- #21-22-2: Kishwaukee Road (FAS 1069) DOT Crossing #372350T

Project converted from Advanced Construction to current status:

- #1-21-3: IL 251 from Kishwaukee Street to east of 9th Street in Rockford
- #1-18-10: IL 173 culvert 0.2 miles east of IL 76
- #1-17-7: I-39 0.8 miles north of Blackhawk Road to I-90; US 20: I-39 to 0.3 miles east of Kishwaukee River; Harrison Ave: Bell School Road to I-39

Mr. Molina reported that on the following projects: Belvidere Road from 173 to Village of Roscoe for an April bid; Owen Center Road is scheduled to meet with the State in early February, construction in 2024; Riverside IDS for Forest Hills and Alpine are nearing completion; Bell School Road from Guilford to Argus Drive Phase 1 is nearly complete, with construction scheduled for later in 2023; Perryville Bike Path nearing bid in April or June; SPR grant of \$680,000 for asset management data collection.

Transportation Alternative Program call for projects received just one application from City of Belvidere with \$600,000 available. Additional follow up and discussion will be forthcoming.
