6. MPO METROPOLITAN TRANSPORTATION PLAN (MTP) – PREFERRED SCENARIO:

Ms. Turner provided a brief summary regarding the 2050 Metropolitan Transportation Plan (MTP) – Preferred Scenario Draft.

The preferred scenario is comprised of four policy areas: transportation, economic, land use and development, and technology. While local governments are not required to implement the preferred scenario strategies, there are land use and transportation strategies that could be employed that would help the region move closer to the preferred scenario. The strategies are intended to be flexible and can be reconsidered over time. Most importantly, the preferred scenario is intended to help local governments, key stakeholders, and the public have a unified vision for the year 2050. Ms. Turner stated no action is necessary and the MPO is looking for concurrence from members to move the preferred scenario criteria forward. The were no objections from MPO Technical Committee regarding the MTP materials as presented.

7. MPO METROPOLITAN TRANSPORTATION PLAN (MTP) – EVALUATION CRITERIA:

Ms. Turner provided a brief summary regarding the project evaluation material for the fiscally-constrained and illustrative project list in the MTP. The MPO based the evaluation criteria on FHWA/FTA's planning factors, MTP goals, investment priorities, and adopted MPO STBG/TAP selection criteria. The goal of the evaluation criteria is to determine how projects align with regional goals and priorities.

Ms. Turner stated no action is necessary and the MPO is looking for concurrence from members to move the preferred scenario criteria forward. The were no objections from MPO Technical Committee regarding the MTP materials as presented.

Mr. DeLille reported that starting in FY 2021 the state will be collecting pavement data down to the collector level. Discussions at IDOT are still ongoing regarding data processing and condition rating information.
