1) Call to Order

With a quorum present, Mr. Dunn called the meeting to order at 2:01 pm.

2) Roll Call

3) Vote to Permit Remote Member(s) to Participate

Mr. Dunn entertained a motion to allow City of Rochelle to participate remotely. Loves Park made a motion to approve, seconded by Boone County, approved unanimously.

4) Public Comment

5) Approval of May 4, 2023 Minutes

Mr. Dunn entertained a motion to approve the May 4, 2023 minutes. Loves Park made a motion to approve, seconded by Belvidere, approved unanimously.

6) Approval of FY 2024 Budget

Mr. Dunn entertained a motion to approve the FY 2024 budget. Boone County made a motion to approve, seconded by Belvidere.

Mr. Dunn explained the budget report and opened the floor to questions. A discussion ensued. Budget approved unanimously via roll call vote.

7) Appointment of Treasurer

Mr. Setter explained that a treasurer position was written into the bylaws at the start of the land bank and elected for a three-year term.

Loves Park nominated Boone County as the Treasurer and Belvidere seconded. Approved unanimously by roll call vote.

8) Property Acquisition Approval

Mr. Dunn entertained a motion to approve the list of properties. Roscoe made a motion to approve, seconded by Boone County. Motion approved unanimously via roll call vote. Mr. Setter explained that Martha St may be a deed-in-lieu of foreclosure, a different acquisition method than the assumed judicial deed, if the property owner was willing to sign the agreement.

9) Property Disposition Approval

Mr. Dunn entertained a motion to approve the disposition of the properties. Belvidere made a motion to approve, seconded by Rockford. Mr. Setter explained how the properties were acquired, what work was done under the ownership of the land bank, and who the purchasers are. Motion approved unanimously via roll call vote.

- b) 727 Bruce St, Rockford Mr. Escamilla as the highest bidder, with Mr. Shun as a backup bidder.

10) Staff Report

Mr. Setter explained that the US EPA awarded R1 a Brownfield Coalition Grant with Winnebago County, Boone County and RMTD. The funding covers Phase Is, Phase IIs, and cleanup planning. The brownfield work will be a great compliment to the land bank work. A discussion ensued.

Mr. Dunn mentioned that the acquisitions were still very Rockford-centric and asked how we can branch out into more areas of NILBA's jurisdiction. A discussion followed.

Mr. Dunn brought up that him, Mr. Setter, and Mr. Denzin spoke with Senator Chesney this morning regarding funding of land banks at the state level.

Mr. Dunn explained that staff and the legal team are monitoring a Supreme Court ruling regarding the operation of county trustee programs. A discussion followed.
