Mr. Setter gave an update on current inventory including the three RPS 205 sites (specifically Dennis School and that R1 put out a request for proposals for the site and have received several good responses) and two land bank houses. Mr. Setter then explained the four properties currently in line to get judicial deeds in January.

Mr. Setter and Mr. Dunn explained that eProperty is working on an updated sales system that allows for more of a live-bid system. This will help with a more transparent and credible sales system.

Mr. Dunn gave an update on the Stellantis project and status of the purchase agreements.

Mr. Dunn then gave an update on the multifamily development with RPS 205. A reputable developer from Chicago wants to build an apartment complex for young professionals.

Mr. Dunn reiterated that staff is continually working on funding opportunities for Illinois Land Banks to recommend in the spring session.

Mr. Thompson (Loves Park) asked if the Land Bank could list properties owned by the City of Loves Park. Mr. Dunn and Mr. Setter explained that R1 could put the property on the sales site but that the city would still own the property and would just be utilizing the eProperty sales service provided by the Land Bank. South Beloit has done this in the past.
