Mr. Vlk reported that Phase I process for Bell School and State Street project is scheduled for a June letting. The sewer projects down at Baxter Road that includes a recycling project is anticipated to go out to bid in late spring.

There are three (3) items on the IDOT April letting; (1) box culvert on South Alpine Road (2) ITEP project Rails to Trails conversion of the Bell Road River Bridge near Davis Park (3) HSIP project at Rockton/Custer.

Mr. Lundin stated that he has not heard any new news on US-20 over the Tollway which would be the major project. The idea is to relocate Wheeler Road and Ipsen Road but they will have to raise the bridges due to the spanning of the Tollway. The question is who is paying for it?

2.34 Rockford Metropolitan Agency for Planning:

Mr. Diipla reported that the RMAP Policy Committee has selected Mr. Michael P. Dunn, Jr. as the new Executive Director for RMAP. Mr. Dunn, Jr. will start on Monday, February 23, 2015.

Mr. Hren provided Administrative Modification on the following projects:

- Project 3-13-40, Intersection Improvements at the intersection of Rockton Avenue and Halsted Road, has a cost update from \$395,000 to \$410,000. The Federal monies are unchanged, meaning that the Sales Tax funding rises from \$125,000 to \$140,000.
- Project 3-11-4, Signal Modernization and Geometric Improvement of the intersection of 15th Avenue and 9th Street is to be removed from Table 11 at the request of the lead agency.
- Project 3-11-5, Pedestrian Countdown Signals at the intersection of East State Street and Fairview Avenue is to be removed from Table 11 at the request of the lead agency.

Mr. Diipla stated that US Transportation Secretary Anthony Fox has unveiled a Long Range Study looking at the transportation network throughout the nation and it is titled Beyond Traffic 2045. RMAP is currently going through the document to look at some of the information compiled.

3. RMAP 2040 LONG RANGE TRANSPORTATION PLAN (LRTP) UPDATE:

Mr. Diipla stated that the five year update of the Long Range Transportation Plan (LRTP) is due July-2015. For the last several months the RMAP has discussed with the RMAP Technical Committee and RMAP Mobility Subcommittee the topics that will be updated. The first draft of what RMAP is titling "Transportation 2040 Tomorrow" is of the updated 2040 LRTP and is available on RMAP's website for viewing. RMAP will be holding a series of open houses which are scheduled as follows:

- Tuesday, February 24, 2015 from 10:00a-1:00p and held at the City of Loves Park City Hall (Council Chambers).
- Tuesday, February 24, 2015 from 3:00p-6:00p and held at the Village of Roscoe Village Hall.
- Wednesday, February 25, 2015 from 2:00-6:00p and held at the Regional Design Center, Rockford.

Mr. Diipla thanked members for their time an effort in providing RMAP the information needed to update the LRTP document. Mr. Diipla stated that a brief overview has been crafted of what is contained within the document and RMAP staff has provided in-depth detail over the previous months. The plan itself is broken down into thirteen (13) sections. There has been some data adjustments in terms of the demographics and socioeconomic charts and projects have added and modified to the thirty (30) year table for roadway improvements. The following is brief summary of the presentation the RMAP staff provided to the Technical members regarding the updates to the LRTP:

ROADWAY

- Explains existing roadway network and future improvements
- Details future improvement projects put forward by local jurisdictions within the 30 year time frame of the LRTP
- Discusses new technologies and their potential impact on transportation
- Current Functional Classification System.
- Future Improvements Table

TRANSIT

- Details cooperative efforts between transit providers and other resource agencies
- Provides financial information on expenditures and revenues for the time horizon of the plan
- Explores expansion of public transit services within the planning area
- Explores the link between land use, the location of new job centers, and transit service

BICYCLE AND PEDESTRIAN

- Details the Implementation of the Bicycle & Pedestrian Plan
 - Beginning in late 2015 RMAP staff will begin the update to the Current Bicycle and Pedestrian Plan
 - Integrate Healthy Communities and Active Transportation
- Walkability Study

ENVIRONMENTAL AND GREEN PLANNING

- Focuses on Climate Change and Green Planning Initiatives
 - o The Relationship between Transportation and Environmental Planning
 - o Past & Current Projects Linking Transportation and Environmental Planning

- Submittal of the adopted LRTP to IDOT and USDOT (FHWYA & FTA)

4. FY2016 UNIFIED WORK PROGRAM (UWP):

Mr. Diipla stated that RMAP has received the planning marks from IDOT. The FHWA/FTA dollars are at the 8/12 level. Once the actual the amounts have been authorized by congress a new table will be printed. Mr. Diipla stated that we are at a smaller rate than last year but RMAP anticipates receiving the full amount within the next few months.

Mr. Diipla stated to members that if there were any projects they felt would be beneficial to add to the UWP, please contact Gary McIntyre at RMAP. The draft will brought forward to the Technical Committee in March, with the final document being brought forward to the Technical and Policy Committee in May-2015.
